3. COMPOSITION / INFORMATION ON INGREDIENTS:

7. HANDLING AND STORAGE:

Precautions for Safe Handling: Keep container tightly sealed. Store in cool, dry location in tightly closed containers. Ensure good ventilation at the workplace. Open and handle the container with care.

Conditions for Safe Storage: Store away from oxidizing agents. Keep container tightly sealed. Store at room temperature. Store in cool dry conditions in well sealed containers.

8. EXPOSURE CONTROLS/ PERSONAL PROTECTION:

Engineering Controls: The usual precautionary measures for handling chemicals should be followed. Keep away from food, beverages and feed. Remove all soiled and contaminated clothing immediately. Wash hands before break and at the end of the work. Store all protective clothing separately. Maintain an ergonomically appropriate working environment. Wear protective equipment. Type B gloves are recommended when high dexterity is required as for TIG welding, while type A gloves are recommended for other welding processes. The contact temp (°C) is 100 and the threshold time (seconds) >15.





Eyes protection: Welder's helmet or face shield with colour absorbing lenses. Shield and filter to provide protection from harmful UV radiation, infra red and molten metal approved to standard EN379. Filter shade to be a minimum of shade 9.

Skin protection: Heat-resistant protective clothing. Wear safety boots, apron, arm and shoulder protection. Keep protective clothing clean and dry. Clothing should be selected to suit the level, duration and purpose of the welding activity.

10. STABILITY AND REACTIVITY:

Chemical Stability: This product is stable under normal conditions.

Hazardous Reactions: Contact with chemical substances like acids or strong bases cause generation of gas.

Conditions to Avoid: Excess heat, temperatures at or above 225° C

Incompatible Materials: Oxidizing agents. Reaction with strong reducing agents such as metal hydrides, acetic anhydride or alkali metals will generate hydrogen gas which could create an explosive hazard.

11. TOXICOLOGICAL INFORMATION:

Acute Effects: Toxicity reported for borates in humans: ingestion or absorption may cause nausea, vomiting, diarrhea, abdominal cramps, anderythematous lesions on the skin and mucous membranes. Other symptoms include: circulatory collapse, tachycardia, delirium, convulsions and coma. Death has been reported to occur in infants from less than 5 grams and in adults from 5 to 20 grams. Potassium Biflouride is extremely destructive to tissue of the mucous membranes and upper respiratory tract, eyes and skin.
