6. Accidental release measures

Close valve after each use and when empty. Protect containers from physical damage; do not drag, roll, slide, or drop. When moving containers, even for short distances, use a cart (trolley, hand truck, etc.) designed to transport containers. Suck back of water into the container must be prevented. Do not allow backfeed into the container. Purge air from system before introducing gas. Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt. Do not re-use empty containers. Avoid prolonged or repeated contact with skin. Avoid prolonged exposure. Use only in well-ventilated areas.
