### Precautions for safe handling

Do not smoke while using or until sprayed surface is thoroughly dry. Do not cut, weld, solder, drill, grind, or expose containers to heat, flame, sparks, or other sources of ignition. All equipment used when handling the product must be grounded. Close valve after each use and when empty. Protect containers from physical damage; do not drag, roll, slide, or drop. When moving containers, even for short distances, use a cart (trolley, hand truck, etc.) designed to transport containers. Suck back of water into the container must be prevented. Do not allow backfeed into the container. Purge air from system before introducing gas. Use only properly specified equipment which is suitable for this product, its supply pressure and temperature.
